i. Discuss and vote on whether to review the damage award in *Iowa Civil Rights Commission*, ex rel v. Rzonca pursuant to Rule 4.23(2), which says "The commission may initiate review of a proposed decision on its own motion at any time within 60 days following the issuance of such a decision.

If a withdrawal occurs the damages can be reviewed, currently they can only be lowered. No motion is needed, all commissioners have an opportunity for comment.

Commissioner Mandsager discussed the AAG presence on case reviews. General conversation around historic cases from Commissioner Ordaz, Commissioner White discussed recalling the last case not advising as much as guiding the commission as on track. Commissioner Mandsager suggested some education around the format of the order.

Request was made to have an AAG at the next hearing.
