Unapproved Minutes-Meeting of the Iowa Civil Rights Commission February 16, 2024

I. Roll Call

Meeting called to order by Chair Ordaz at 1:15 pm. Commissioners De Kock, Kennedy, Mandsager, Ordaz, and White appeared in person. Commissioners Kooiker appeared via Zoom.

III. Approval of Minutes from September, October, November 2023 meeting.

Minutes from the previous meeting were presented and Commissioner Mandsager had recommended corrections to November and emailed recommended changes. Daniel motioned to approve with Mandsager second. Approved.

Commissioner White motioned to move the standing business agenda item before standing business, Commissioner Kennedy seconded. Approved by unanimously.

Public Comment Written or Oral: Ralph Rosenberg spoke on the topic of legislative priorities focused on the boards and commissions and powers and duties within 216.
