- What budget covers the cost of AG office when we need the legal support for case reviews?
- When is the budget due for upcoming year request

What were the intentions behind the way the roles are written now?

Information exchange, what can we do. For example, can Commissioner De Kock go in and review cases? What is the ED doing directionally and what can we do to support? Monthly report to show what the case load trends are?

Is there a way we can let the public know the change of function of the commission?

Service animal is a known trend – likely something we can get behind and find out what other states are doing? Who were the sponsors/cosponsors of the bill?

Move forward with 3 points: De Kock with legislators, understanding the intentions behind the changes and awareness of the effects – including the loss of educational involvement, access to cases / visibility, inviting them to 10/18 meeting. 2. Ordaz to discuss with Director Stiffler when she will be back and if she can do monthly director reports and AG reports again, and understanding her intentions as well. Discuss budget and reporting of appeals. 3. Setting up a planning meeting prior to 10/18. Planning on 8 am on Friday, October 4.
